Subj: QUARTERLY CRIMINAL ACTIVITY, DISCIPLINARY INFRACTIONS AND COURTS-MARTIAL REPORT (QCAR)

1. Purpose. To issue revised military justice statistical reporting procedures as set forth in reference (a) for Naval Service Training Command and its chain of command subordinate activities.
2. Cancellation. NSTCINST 5800.1.
3. Background. Reference (a) directs Officers Exercising General Courts-Martial Jurisdiction (OEGCMJ) to submit quarterly reports to the Judge Advocate General. Negative reports are required.
4. Reporting. Enclosure (1) is to be used when submitting quarterly feeder reports to the Staff Judge Advocate (SJA) of OEGCMJ.
5. Scope. For reporting purposes, Commander, Naval Service Training Command is the OEGCMJ for the following activities and any and all of their chain of command subordinates.
 - a. Recruit Training Command
 - b. Officer Training Command Newport
 - c. Naval Reserve Officers Training Corps
6. Action. Unless otherwise directed, subordinate commands identified in paragraph 5 shall submit enclosure (1), no later than 15 January, 15 April, 15 July and 15 October for the previous quarter.
