- (1) **Paper copies of all above listed documents must be provided to the Learning Site Staff along with trainees' orders.**
- (2) Trainees will be required to take a course pretest and pass with a score of 70% or better to be enrolled in class. Trainees scoring 69% and below will not be enrolled and returned to their commands (if TAD) or placed in HOLD Status (if PCS). Pretest consists of rules of the road, basic seamanship, and basic navigation skills. Practice test are listed in CANTRAC on the CDP link.
- (3) Ensure students report to class with Foul/Cold Weather Personal Protective Equipment (PPE). Learning site has limited equipment available.

If Sailors do not have a government credit card (highly recommended), advanced pay is required. Students shall not schedule a return flight any earlier than 1300 on the day of graduation. RENTAL CARS ARE HIGHLY RECOMMENDED due to the distance from NGIS and Navy Lodge to the Learning Site. Learning Site Little Creek does NOT provide transportation to and from the local airports.
