

TEMPORARY TERMINATION OF NROTC CONTRACT  
TO FACILITATE ATTENDANCE AT THE UNITED STATES NAVAL ACADEMY (USNA)

**Parties:** The parties, Midshipman \_\_\_\_\_, (“MIDN”) a student and member of the NROTC at \_\_\_\_\_ (“University”), and the U.S. Navy (“Navy”), agree to the terms of this Temporary Termination Agreement (“Agreement”) in regard to NSTC 1533/135 NAVAL RESERVE OFFICER TRAINING CORPS (NROTC) SCHOLARSHIP CONTRACT dated: \_\_\_\_\_ (“Contract”).

**Appointment to United States Naval Academy.** The MIDN has been offered and has accepted an appointment into USNA for one semester with a start date of \_\_\_\_\_. MIDN will not be attending UNIVERSITY or participate in the NROTC program while appointed as a MIDN at the USNA.

**Termination of NROTC Contract.** The Contract shall be terminated effective \_\_\_\_\_ to allow MIDN to be appointed in the USNA for the \_\_\_\_\_ (Fall or Spring) semester of \_\_\_\_\_. It is the intention of the parties that this is a temporary termination of the Contract.

**Recoupment of Debt to the United States.** The parties acknowledge that MIDN has a debt to the United States for payment for tuition, fees and books, or payments made for room and board, as established by the terms of the Contract. The parties further acknowledge that this debt is not forgiven by the terms of this Agreement. The Navy agrees to hold recoupment in abeyance, and there will be no demand for repayment of the debt during the time the Midshipman is on active duty at USNA. Nothing in this agreement shall be construed to modify the terms of repayment or the amount the debt, that except there will be no collection of the debt for the period of time MIDN is on active duty at USNA.

**Return to the NROTC Unit and Reinstatement of Contract.** Upon completion of the semester (or earlier release from) USNA, MIDN shall report to the NROTC Unit at UNIVERSITY on or before \_\_\_\_\_ and complete all tasks necessary to re-enroll in UNIVERSITY NROTC unit and reinstate the Contract. MIDN shall also enroll for classes at UNIVERSITY to complete the baccalaureate program and continue participation in the NROTC program.

**Failure to Return to University or NROTC Unit.** In the event MIDN fails to return to UNIVERSITY or the NROTC Unit as required above, the Contract shall be considered terminated, and the disenrollment shall be processed as a Failure to Enroll. The Navy may then proceed with recoupment of all tuition, fees, cost of books, room and board payments, or other amounts due under the Contract, pursuant to applicable laws and regulations.

**No Oral Representation.** No oral or written representations have been made other than as stated, or in addition to those stated in this Agreement, and MIDN is not relying on any oral statements made by the Navy’s representatives concerning this Agreement.
