1. Purpose. To publish a revised Naval Service Training Command (NSTC) Command Inspection (CI) schedule.

#### 2. Background

a. Reference (a) establishes objectives, policies, and responsibilities for executing the NSTC Command Inspection Program (CIP). The NSTC CIP is part of the Department of the Navy Inspection Program (DONIP) which is a coordinated program of inspection that focuses on unit readiness and capability to execute assigned missions, current and projected, for the purpose of informing senior naval leaders of the Department of Navy's overall ability to accomplish its mission.

b. This instruction identifies inspected units and inspected processes. This is for planning purposes and may be changed, added to, or deleted based on mission requirements. Specific dates and requirements will be coordinated with the commands and activities to be inspected at least 120 days in advance if possible. Requests for changes to the schedule should be submitted to NSTC Inspector General as far as possible in advance of the scheduled inspection dates.

3. Action. Commands and activities will prepare for Command Inspections per reference (a).

4. Records Management. Records created as a result of this notice, regardless of media or format, must be managed per Secretary of the Navy Manual 5210.1 of September 2019.
