 - c. If not selected by the NSTC Advance Standing Selection Board following my 2/C year, I will be released from service with no obligation.
- d. If selected by the NSTC Advance Standing Selection Board for either Advanced Standing or for a one-year scholarship and I choose to accept, I will be required to sign the appropriate service agreement contract and incur a military service obligation.
- e. I understand that I must complete all Naval Science requirements and such courses as are prescribed by the NROTC Regulations and the NROTC Academic Program in addition to the requirements of my major.
- f. I may obtain employment while in college, provided such employment does not interfere with my academic instruction, Naval Science drills, and summer training.
- g. The Commander, NSTC may release me from my obligations under this agreement and separate me from the training program at any time, that in the opinion of the Commander, NSTC, such action is required in the best interests of the naval service. As well, I may also provide written notice if I decide to no longer participate in the provisional CPAS program without incurring any obligation.
- 2. I have read and completely understand the meaning and content of the above. This contract is subject to the Regulations of Officer Development for the NROTC Program. No promises, either written or oral, have been made to me in connection with my application for enrollment in the NROTC College Program, except as specified above.
