

Streamlining Point Defense: Integrating Phalanx and SeaRAM PQS by John Hull, SCSTC PQS Program Manager

The U.S. Navy's layered defense strategy relies heavily on the Close-In Weapon System (CIWS) to protect ships from high-speed threats. However, as ship classes increasingly feature mixed combinations of Phalanx and SeaRAM systems, Sailors have faced challenges navigating two separate



Personnel Qualification Standards (PQS) manuals: NAVEDTRA 43373-G for Phalanx and NAVEDTRA

43373-31B for SeaRAM. Recognizing the need for clarity and efficiency, an effort was undertaken to combine these PQS products into a unified PQS NAVEDTRA 43373-2, CIWS MK 15. Despite their

differences, both systems share common subsystems and





operational principles, such as radar tracking, threat prioritization, and fire

control. This approach promotes an understanding of point defense operations across diverse ship classes. Bridging the gap between Phalanx and SeaRAM has created a more cohesive and effective training standard, empowering Sailors to safeguard their ships in an ever-evolving threat environment.


